

RESOLUTION OF APRIL 21ST, 2020, OF THE CONSORTIUM OF COMMERCE, CRAFTS AND FASHION OF CATALONIA, APPROVING THE REGULATORY BASES FOR THE GRANTING OF SUBSIDIES IN THE FIELD OF TRADE, SERVICES, CRAFTS AND FASHION ECONOMICALLY AFFECTED BY COVID-19

The Government of Catalonia has approved the regulatory bases for the granting of different subsidies to persons economically affected by COVID-19 in the field of trade, services, crafts and fashion, pursuant to the resolution of 21 April 2020 of the Consortium of Commerce, Crafts and Fashion of Catalonia.

The purpose of the grants is to reactivate and boost the sectors that will benefit from the various programmes, with the maximum amount allocated to subsidies of EUR 7900000.00 in the field of trade, EUR 600000.00 in the field of crafts and EUR 500000.00 in fashion.

WHO CAN BENEFIT?

The natural and legal persons who may benefit from the subsidies are:

- Self-employed professionals discharged from the RETA.
- Individual, associated or grouped companies registered in the IAE census.
- Local governments and public bodies seconded or linked.
- Territorial entities, trade unions and non-profit sector entities.
- Associations of sedentary and non-sedentary municipal markets.

Applicants for grants shall comply with the requirements laid down in the regulatory bases for obtaining the status of beneficiary.

HOW AND WHEN CAN IT BE REQUESTED?

Applicants must submit the standard model accompanied by the other documentation required for each program through the website

<http://canalempresa.gencat.cat> within the deadlines indicated in the table below.

Only one application may be submitted for each programme and the amount of the grant awarded shall be determined by assessing, among other factors, the cost of

the project submitted by each applicant, who shall carry out the actions for which the grant is applied for during the year 2020.
